DASAR ALAM SEKITAR

KIAN JOO CAN FACTORY BERHAD (KJCF), syarikat terkemuka dalam percetakan logam dan pembuatan tin, berkomited untuk melaksanakan amalan terbaik dalam melindungi alam sekitar, mencegah pencemaran, dan menangani perubahan iklim. Kami berusaha untuk mengintegrasikan pertimbangan berkaitan alam sekitar dan iklim ke dalam semua aspek yang berkaitan dengan konteks operasi perniagaan kami.
